Terms & Conditions

1. Pre-Qualification of Firms fulfilling above mentioned criteria is required for the following types of Civil Works / Repair Maintenance Services and Replacement of Accessories Services etc at Regional Directorate ANTI NARCOTICS FORCE, Old PIA Cargo Sheds VIP Flight Complex Road Near Ayyub Stadium Lahore for Financial Year 2026-27:-

 - ✓ Repair / Maintenance of Sewerage Lines
 - ✓ Electric Repair / Maintenance / Replacement Work
 - ✓ Sui Gas Repair / Maintenance / Replacement Work

5. All the proposals and prices shall remain valid upto 30 June 2027 for the financial year 2026/2027 from the closing date of the submission of the proposal / tender.
6. The firm providing unsubstantiated and/or incorrect information are liable to legal action and disqualification from the bidding.
7. The firms should provide undertaking and original affidavit on judicial stamp paper for non-blacklisting from any Government Department and other Semi Government of firm.

Forfeiture of Earnest Money and Blacklisting of Firm

16. In case of submission of any false information / documents and any deficiency found in deliverables, the Earnest Money will be forfeited and the firm would also be disqualified/ blacklisted.

Corrupt or Fraudulent Practices

17. The Purchaser observes the highest standard of ethics during the procurement and execution of such contracts. In pursuance of this policy, the Purchaser:-

- (i) Defines, for the purposes of this provision, the terms set forth below as follows:
 - (a) "corrupt and fraudulent practices" includes the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official or the supplier or contractor in the procurement process or in contract execution to the detriment of the procuring agencies; or misrepresentation of facts in order to influence a procurement process or the execution of a contract, collusive practices among bidders (prior to or after bid submission) designed to establish bid prices at artificial, non-competitive levels and to deprive the procuring agencies of the benefits of free and open competition and any request for, or solicitation of anything of value by any public official in the course of the exercise of his duty
- (ii) Will reject a proposal for award if it determines that the Bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question;
- (iii) Will declare a firm ineligible and blacklisted for future participation either indefinitely or for a specific period of time as may deem appropriate by the competent authority of this Ministry being procuring agency.
